Subject: Election of Post Officers

The Department Convention for 2023 will be held June 16-June 18, 2023.

The American Legion By-Laws, Article VI, Section 2A, states: Post Officers shall be elected and installed annually before the Department Convention. It shall be the duty of the Post Adjutant to certify to Department Headquarters, on the forms provided for that purpose, the names and eligibility of the newly elected officers immediately after their election.

In the event a Post does not elect, install and certify to Department Headquarters, Post Officers, as provided in this Section, the District Commander shall appoint necessary officers for such Post.

As our Department Convention starts on June 16, 2023, it is necessary that you have your election of officers, installation and certification to the Department before June 1, 2023.

Enclosed you will find the form necessary for certification. (THESE HAVE TO BE FILLED OUT, FRONT AND BACK, EVEN IF YOU HAVE THE SAME OFFICERS AS LAST YEAR). Please make sure the forms have been received at Department Headquarters as soon as possible after your election(s). Thank you for your help.

Section 2-A. Post officers shall be elected and installed annually before the Department Convention. It shall be the duty of the Post Adjutant to certify to Department Headquarters, on forms provided for that purpose, the names and **ELIGIBILITY** of the newly elected officers immediately after their election.

Section 3. It shall be the duty of all Post officers elective and appointive, to submit to Department Headquarters within fifteen days of election or appointment, certified copies of documents establishing eligibility to membership in The American Legion in accordance with the qualifications prescribed by the Department Constitution. If such evidence of eligibility be not submitted within the above required time, the office of the person failing to submit such proof shall be declared vacant by the Department Commander and shall be filled in the same manner as a vacancy in such office otherwise occurring. **(This section added by amendment on August 17, 1932, and was amended on September 4, 1935.) That all Post Adjutants be required and instructed to transmit to Department Headquarters the names of officers at once, upon election and their meeting dates and all other pertinent facts pertaining to the post.**
